### Maharashtra receives Rs 1.13-lakh-cr FDI

**MUMBAI:** Maharashtra has attracted Rs 1.13lakh-crore in foreign direct investment (FDI) in the first six months of FY 2024-25, Chief Minister Devendra Fadnavis announced. This figure is nearly equivalent to the total FDI the state received 94.71pc of the has received annually over the last four years.

In a post on X, Fadnavis said that Maharashtra received Rs 1,13,236 crore in FDI during the ends in Sept 2024.

Comparing this to previous years, the state received Rs 1,19,734 crore in 2020-21, Rs 1,14,964 crore in 2021-22, Rs 1,18,422 crore in 2022-23, and Rs 1,25,101 crore in 2023-24.

"This means the state FDI in just six months compared with the annual average of the last four years," Fadnavis wrote in his post.

### **UAE** to remain fastest growing economy in

ABU DHABI: In 2025, the UAE is set to remain growing fastest economy in the GCC region due to its ability to increase oil production earlier than other Opec+ nations a recent report said.

According tothe CEO Outlook report by KPMG, the UAE's economy is forecast to achieve 6.7pc growth in 2025, a significant increase from 3.8pc this year. This is likely to be primarily driven by its distrong trade relation- to the Department of ships with neighbouring countries. "The nation's positive economic outlook is supported by its thriving tourism sector and continued economic expansion," KPMG noted.

we estimate a growth of approximately 15-20pc in office staff roles, particularly in Dubai, as new companies set up operations and established businesses scale their teams," said Ravi Jethwani, CEO of Innovations. "The demand for skilled office support roles - such as admin assistants, HR professionals and finance staff, staff - remains strong as companies focus on operational efficiency and talent retention."

Hiring experts agree with this sentiment and rate 2025 as offering more of the same sort of growth patterns for office staff. With office positions, the trend continues to be to outsource where possible. It makes sense for newly set up companies to opt for this to keep their HR costs down -- and not use up visas on what are essentially non-core roles.

"There is significant demand for temporary

Office jobs in high demand in... especially roles that are more project-based or seasonal," said Jethwani. "Many startups and SMEs - who may not want to commit long-term employment contracts initially are opting for temporary staff or outsourcing certain roles.

"These companies may prefer working with recruitment agencies to manage temporary or contract staff on their behalf, thus allowing flexibilithem more ty and cost-efficiency during the initial stages of their operations, " said an HR expert.

# Is it legal to work in UAE while on a visit

I am in the UAE on a visit visa. I was recently offered a job by a mainland company. My boss has asked if I would be willing to start working as the company gets the work permit/visa application done. Am I allowed to work after accepting a job offer but before my permit/visa is processed?

In the UAE, an emplover may not recruit an individual without a valid work permit under Article 6(1) of the Federal Decree Law No. 33 of 2021 on the Regulation of Employment Relations, which states: "No work may be performed in the UAE, and no employee may be recruited or employed by any employer without obtaining the work permit from the



ministry, in accordance residency visa. This is in with the provisions of this Decree-Law and its Executive Regulations."

Furthermore, an expatriate may not be engaged in any employment in the UAE without a valid work permit and a valid UAE line with Article 5(4) of the Federal Decree Law No. 29 of 2021 regarding entry and residence of foreigners, which states "An alien (anyone who does not have the nationality of the State) is obligated not to engage in UAE residency visa, any activity or work except in accordance with the legislation in force in ticle-1 of Federal Dethe State."

work, an employer and an employee may mutually agree to obtain a work permit as stipulated by the Ministry of Human Resources and Emiratisation (MoHRE). The types of work permits may include but are not limited to full-time work permits, part-time work permits, temporary work and freelance permits work permits as mentioned in Article-6 of the Cabinet Resolution No. 1 of 2022 on the Implementation of Federal Decree Law No. 33 of 2021 regarding the regulation of employment relations.

If an employer recruits an individual without a valid work permit and

the penalty may be Dh1 lakh. This is under Arcree Law No. 9 of 2024 Based on the type of revising some provisions of Federal Decree Law No. 33 of 2021 concerning employment relations, which is related to amendment of Article 60(1)(a) of the Employment Law.

> The said law reads as: "Individuals who commit the following violations shall be fined a minimum of Dh1 lakh and a maximum of Dh10 lakh.

> Based on the aforementioned provisions of law, you should not work while you are on a visit visa in the UAE. Instead, you may request that your new employer obtain a work permit and UAE residency visa sponsored by it.

# Is it possible to revoke my 'will' after divorce?

I am a non-Muslim man. Two years ago, I made a will for my wife with all my money and I authenticated the will before the competent authorities. Recently, I have divorced my wife and want to cancel the will. My question: Do I have the legal right to cancel the will and make a new will for my children and also attest it before the competent authorities, and what are the legal procedures necessary for that? Does my ex-wife have the legal right to object the cancellation of the will, knowing that she has an original copy of the will?

You have the right to revoke your will and to attest it even if your ex-wife doesn't accept this. The cancellation is better to be done in front of the authority you had made it, weather in front of the Notary Public of Dubai Courts or the DIFC through an application of cancellation. After revoking a will, the testator can make another will in its place or not write a will at all.

Article (29) of the Cabinet Resolution No. (122) of 2023 Concerning the Executive Regulation of Federal Decree-Law No. (41) Of 2022 on the Civil Personal Status, regarding the Lapse of the will, states the cases by which the will shall lapse and in:

\*Where the will is revoked by the testator, provided that this revocation shall be registered on the Register.

\*Where a new will that contradicts the original will is registered.

\*Where the testate property is disposed of in a manner that involves transfer of ownership.

\*In the event of death of the beneficiary of the will during the lifetime of the testator.

\*In the event of destruction of the testate property.

\*Where the testator becomes bankrupt during his lifetime. In the event of renunciation of the will by its beneficiary or his guardian.

\*Where the testator is killed by the beneficiary of the will.

## Can I opt for "visa hold" when switching jobs between emirates?

I have been working in Dubai for the past five years. My family members are under my sponsorship. If I accept a job in Abu Dhabi and move there, do I have to change my family's visa immediately? Or can I use the "visa hold" option till I settle down in Abu Dhabi?

Upon termination of employment by your employer or resignation from employment, the employer should cancel your work permit after you sign the work permit cancellation document. This is in accordance with Article 7(3) of the Cabinet Resolution no. (1) of 2022 On the Implementation of Federal Decree-Law no. (33) Of 2021 Regarding the Regulation of Employment relations, which reads as:

- a) Submission of an application for cancellation of work permit via the channels specified by the ministry.
  - b) Completion of the required information and attachments.
- c) Payment of fines for delay in issuance or non-renewal of work permits, if any.
- d) Declaration by the establishment that the employee has received his entitlements.
- e) Any other conditions specified by decision of the minister or his delegate."

Thereafter, your employer should cancel your residency visa in the UAE. As the sponsor of your family members' residency visas in the UAE, you have the option to place their visas on hold while you transition to a new employment visa. This visa hold service allows you to keep the visas of your family members active for up to 60 days. If you prefer not to cancel the visas, you can inform the authorities of your intention to hold them until you obtain a new employment visa.

To initiate the aforesaid process, you may visit an Amer Centre. You may also approach the General Directorate of Residency and Foreigners Affairs – Dubai or the Federal Authority for Identity, Citizenship, Customs and Port Security as your current visa is issued from Dubai and your new employer visa will be from Abu Dhabi.

# Will Indian nurse Nimisha Priya be hanged in Yemen?

**"**ill Nimisha Priya, a nurse from Kollengode Palakkad district of Kerala, hanged in Yemen? This is the fear in every Indian's mind.

The case of Nimisha Priya, sentenced to death in Yemen, has raised serious questions about the protection of citizens abroad, the role of the Indian government in handling such cases and the broader implications of foreign legal systems on our nationals. As this tragic saga unfolds, it serves as a stark reminder of the challenges that Indians working in foreign countries, especially in conflict zones, face when caught in legal predicaments.

Priya's case is layered with complexity. Initially migrating to Yemen in search of work, she became embroiled in a series of unfortunate events that ultimately led to her conviction for the death of a Yemeni national, Talal Abdo Mahdi, who had subjected her to extreme torment. Her story reflects the harsh realities of foreign employment particularly for women where individuals are often at the mercy of local laws and powerful individuals. In Priya's case, allegations of exploita-

tion, torture and coercion have emerged, but despite these, the Yemeni judicial system has held her accountable for a crime that led to the death sentence.

The Indian government's response has been to offer diplomatic support, including exploring the possibilities of blood money compensation or a presidential pardon. However, such options highlight a painful truth: New Delhi's reach is limited when citizens face the full brunt of foreign legal systems. The Ministry of External Affairs has stated that it will extend "all possible help" to Priya, but this statement raises the question of what "help" truly entails. While the government can push for negotiations diplomatic and legal interventions, such as facilitating the payment of blood money, these efforts are often insufficient against the backdrop of a foreign justice system that may not be entirely transparent or impartial.

The role of blood money in obtaining pardons also underscores the disparity between what is just and what is politically or culturally acceptable in different legal contexts. Should an Indian national's fate depend on her or

his ability to financially compensate the victim's family, rather than the merits of the case? Moreover, the emotional and legal burden on Priya's family is immense. Her mother's journey to Yemen to negotiate a resolution, despite the risks involved, underscores the desperation and helplessness many families experience when their loved ones face serious legal trouble abroad. The Indian government's approval of her travel, given the volatile political situation in Yemen, further exemplifies how complex and perilous the diplomatic process can be when citizens are caught in such situations.

Priya's case is not isolated. It highlights the broader issue of Indian nationals working in foreign countries with limited protection. This case, fraught with legal, cultural and diplomatic challenges, should prompt a reevaluation of how India addresses its citizens' safety and rights in foreign lands, especially in nations where legal systems may not be aligned with India's values of justice and fairness. Priya is a victim in more senses than one and India must exert its influence to en-
